ALUMNUS SPEAKS AT CONVOCATION



BCIT graduates have a vital role to play in finding solutions to the ecological crises, according to Dick Tomkinson, the 1976 convocation speaker.

A BCIT alumnus, Tomkinson delivered his address on June 11th to 342 members of the 1976 graduating class, their families and friends. The convocation ceremony was held in the SAC Cafeteria.

In his speech, Tomkinson challenged the graduates to share their specialized skills with the global village and use their intellects in the struggle to preserve our environment.

"It is technology - applied to the practical problems of society at large - that is at the cutting edge of maintaining humanity in this world," Tomkinson said.

Referring to H.G. Wells' depiction of history as a race between catastrophy and science, he

continued: "Technology, the applied intelligence of man, is the power and the factor that will carry human habitation on this planet through the growing scarcity of energy and material into a new world."

As support for this thesis, Tomkinson pointed out that we live in an ever-expanding world. Our growing ability to measure in ever smaller and more precise units increases the amount of time we have. Advances in medicine extend our life-span. New techniques in exploration increase the availability of resources. Space travel expands our horizons. These factors, according to Tomkinson, increase our capability of solving the problems of a crowded planet.

Tomkinson graduated from BCIT in Business Administration in 1966. He is presently branch manager of Sperry Univac Computer Systems in Montclair, New Jersey. Prior to that, he was area manager for that company in South Africa.

1976 ANNUAL GENERAL MEETING

The 1976 Annual General Meeting of the BCIT Alumni Association was held at BCIT on June 29th, 1976, under the chairmanship of the outgoing President, Mark Bailey. The reports of the Executive and Directors were received and election of new officers and directors carried out.

The 1975-76 year was a period of re-organization and adjustment. Presentations to the Board of Governors through the Principal, Gordon Thom, had been made and the Association had gained moral, as well as financial, support from the Board. Plans were made for a mail ballot election of an alumni nominee to the Board of Governors, the Administration started work on compiling and

maintaining an accurate Alumni History File; the establishment of a Director of Information Services, including an Alumni liaison function, all set the stage for a concentrated effort by the Association in 1976-77 to establish its credibility with its membership, the institute and community.

The initial priority item for 1976-77 is to establish a communication link with the membership, to solicit feedback and to determine the long term aims and goals of the Association based on the demands of the membership.

ALUMNI MAILING LIST

The Alumni Association mailing list is in the best condition ever as a result of the election of a representative to the Board of Governors.

Thousands of graduates have gone from BCIT in the past twelve years, many of them scattered throughout the world. With the result that addresses obtained at graduation were no longer valid.

Management of a mailing list on an ongoing basis is a time-consuming job, but if there is nothing to manage it becomes the more difficult task of compiling one.

Using old lists, cross-checking them with associations and any other list the administration of BCIT could get hold of, a total of 6,000 names and addresses were compiled and used as the election register. Everyone connected with the project was aware the list was hardly

an accurate one, but it was a starting point. The election was conducted through the mail with return address cards as part of the election kit.

Through return envelopes and address cards, there is now a list of 3,918 verified names which are as current as can possibly be. The list is committed to the computer bank and may be retrieved by year of graduation, technology and geographical location.

The shape of the mailing list is due to the insistence of President, Ron Isaak and the commitment of funds by the administration which allowed a clerk to be put on the sorting job for a full six weeks this summer.

However, one word of caution, the list is only as good as its currency and much effort is going to be required to keep it up-to-date and indeed, to increase it to broaden the base of the Alumni Association.

OPEN HOUSE '77

March 18th and 19th have been set as the days for Open House '77 at BCIT. Of course, we want as many alumni to attend that weekend and to make it even more successful. There will be a special homecoming event for past graduates.

Open House Homecoming will entail a great deal of planning and work and like every other association we need help. Ideas we have now are not carved in rock, therefore creative, stimulating formats for this occasion are very welcome.

Once we have the concept, we need hands on board to help us make it the kind of event that will appeal to graduates and also use it as a major launching program for an active Alumni Association.
