## ANNUAL GENERAL MEETING:

## Alumni Goals Still Top Priority

The goals established early in the year for the BCIT Alumni Association continue to be top priorities for the new Board of Directors, Robert Simons, new president, assured members at the Association's annual general meeting at the British Columbia Club on May 27, 1988.

"We face a tough year," president Simons said, "but alumni, as always, are up to the challenge."

Simons thanked John Leech, outgoing president, for the "tremendous leadership he has provided for the board" and expressed his gratitude to Nicki Magnolo, executive director, and the Alumni staff for their work over the past three years.

In his report, Leech thanked the board members for their work and highlighted the main activities of the Association during the past year. These activities included the

Campus Centre campaign, fund-raising planning for BCIT, marketing planning for BCIT, the Institute's Open House, strategic planning workshops for Association objectives, planning improvements for graduate records, and student aid fund-raising and disbursements.

Leech made a special presentation of a cheque for \$2,000 to the Malcolm Wickson Endowment Fund from the Association. The fund was established in honour of the late Malcolm Wickson, former chairman of the BCIT Board of Governors.

The monies will be used for student scholarships and bursaries, and donations will be matched by the provincial government. Robert Simons and John Leech assisted in the presentation.

Business Telecom Equipment regional manager **Robert Simons** was elected president of the BCIT Alumni Association during the association's annual general meeting last May.

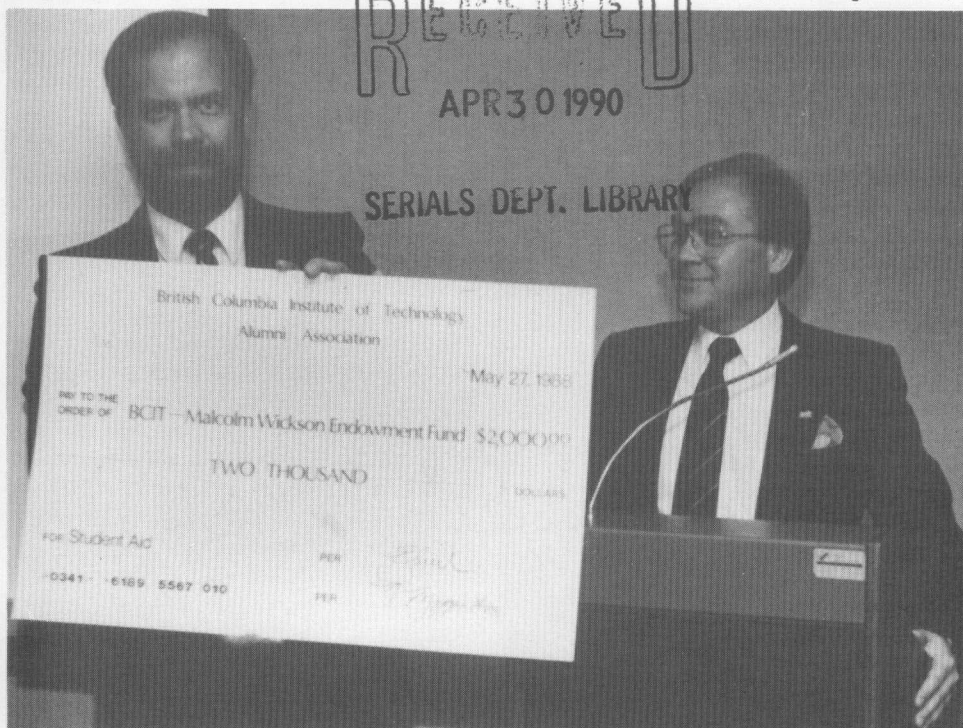
Simons (see profile on Page 3), succeeds John Leech as president. Leech is currently the executive director of the Applied Science Technologists and Technicians of B.C.

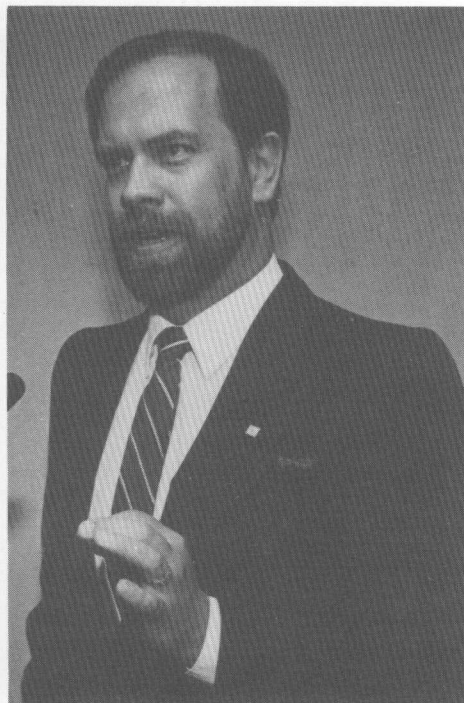

# Alumni Association President Profiled



Robert Simons

What does it mean to be a BCIT alumnus?

The answer probably varies according to one's year of graduation, says Robert Simons, new president of the BCIT Alumni Association and an active alumnus.

A planned major survey of graduates will encourage serious consideration of the question, Simons believes.

And the value individuals attach to being an alumnus will influence the role taken by the Alumni Association in its relationship with BCIT.

Simons looks forward to an active year that will include novel fund-raising projects. Their success will depend on the level of commitment made by graduates to what Simons describes as a "unique school."

"In the first five years after graduation, the Alumni Association could act as a kind of support network to help an alumnus move and position himself or herself in the job market," he suggests.

In this year of transition for BCIT,

Simons predicts an important role for the Alumni Association. "A new wave of technology programs is upon us and BCIT can again take its position in the B.C. educational system to deliver graduates with technological excellence."

A 1972 BCIT Marketing Management grad and past member of the BCIT Board of Governors (BOG), Simons was the recipient of the 1982 annual alumni award "in recognition of perseverance and dedication displayed in ensuring that BCIT would stand out as a learning institute."

Simons also acted as an alumni representative on the 1979 and 1980 BCIT BOG during which time he chaired the Finance Committee and the Education & Student Affairs Committee. The following two years he acted as BOG vice-chairman and member-at-large.

Simons says the Alumni Association has been involved with BCIT in the past and "we could still maintain BCIT as the leading technological training centre for the province. It's a unique school."

In his spare time, Simons and his wife, Valerie, enjoy outdoor recreation and time with their collie, Skye. They travel to other parts of the world every five years, if possible.

Robert Sawka, treasurer, presented the year-end financial statements. He noted that the Association came in under budget for the second year in a row and that expenses for the directors' meetings were higher than usual because of the special workshops that were held.

Nicki Magnolo, executive director, thanked the Trade Show participants and donors of the raffle prizes for their participation in the annual general meeting. She also thanked Ernie Iannacone for his assistance in securing the B.C. Club for the meeting.

For the second time in three years, Nicki said, the Alumni Association was honoured by the Council for Advancement and Support of Education with an award for Alumni Relations Improvement. The BCIT Association was selected for a Bronze Award from among 25 nominations throughout North America.

Nicki thanked the alumni staff, Cheryl Anderson and Ebon Lomas for their work during the past year.

Martin Hendy, the newly appointed director of corporate and community liaison,

observed that budget cuts at the Institute would result in many areas, including the Alumni Association, being reorganized. He noted that the Alumni Association would lose the services of the present staff.

He assured alumni that BCIT is committed to the Alumni Association and that graduate records are a high priority. Alumni fund-raising and the Alumni News will be continued.

He concluded by congratulating the board on the CASE award and spoke of the competitive advantage BCIT grads have in the job marketplace.

Guest speaker Rick Hulbert of the Hulbert Group presented a slide presentation about the proposed development of the Expo site which is being undertaken by Concorde Pacific Development. Hulbert is the key architect for the development project.

## Corporate Chapters Established

A new system of corporate networking has been organized as a way of keeping track of alumni and boosting the Campus Centre campaign. Keeping track is a major problem for BCIT in a highly mobile society, especially if grads forget to inform the Alumni Association when they move.

Many B.C. companies recruit at BCIT each year and some of those employers now have a sizeable number of BCIT grads on the payroll. This is why the Campus Centre Project has moved into the workplace, contacting alumni and organizing alumni corporate chapters.

Corporate chapters have been established at Finning Ltd., Nexus Engineering, and MacDonald Dettwiler. Nexus, through its chief executive officer, Dr. Basil Peters (Electrical 1975), went a step further by introducing a company matching grant program for employees who join him in contributing to the Campus Centre.

Corporate networking begins with a brief presentation in a workplace setting at the end of a workday. The presentation team consists of members of the BCIT administration, the Tower Group, and the Alumni Association. Team members are available to answer questions, during and after the presentation. ## Campaign Draws Closer to Goal

The fund-raising campaign for the Campus Centre has reached more than a third of the way to its goal. The campaign is going so well that the Student Association and BCIT Administration are negotiating possible dates for a ground-breaking ceremony in the spring.

The Alumni component of the Campus Centre is the Tower Group. "We are looking for graduates who believe in our slogan 'it's about time' - alumni who are willing to help financially and, if possible, to donate time," says committee member Lorne Hildebrand.

The Tower Group started as a fundraising vehicle for alumni to contribute to the Campus Centre. In Hildebrand's view, it represents, together with the Centre, a 'coming of age' for BCIT.

The BCIT Student Association is making the planned Campus Centre its special project for 1988-89, says Guy Steeves, president.

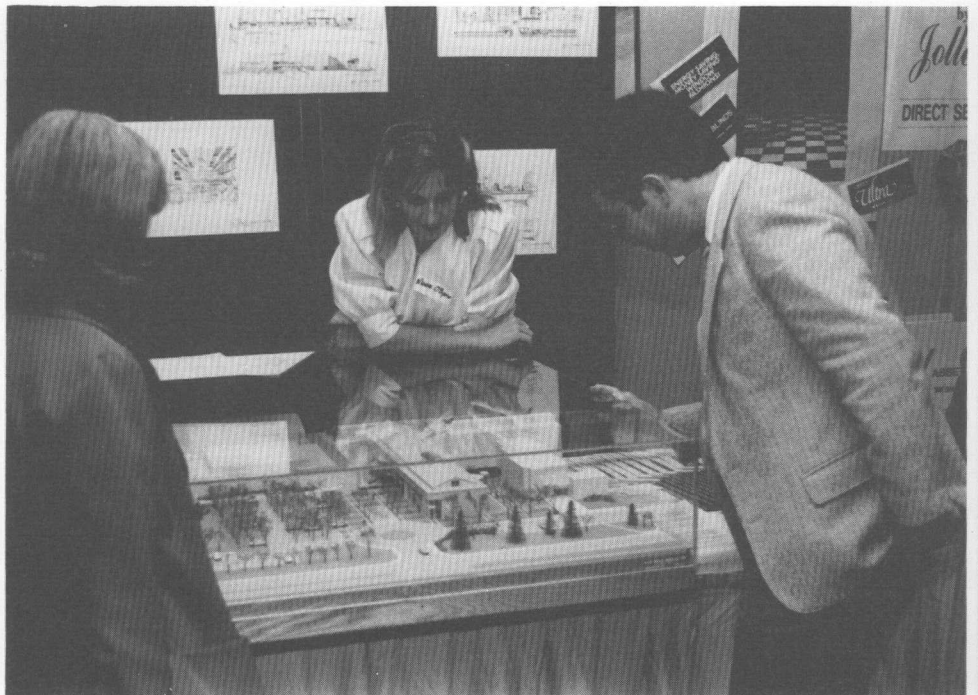
