# **New officers elected**

### President 'confident'

The BCIT Alumni Association elected a new slate of executive officers at its 1982 annual general meeting Thursday, September 23.

Michael Dean, a 1981 graduate from administrative management who served as vice-president last year, was elected president.

Other executive members include: Vinod Chandra, vice-president; Pam Dean, treasurer; and Blaine Kennedy, secretary. Engineering representatives are Guy Foyle and Phil Whyte; business reps, Linda Bell and Grant Crittenden; health reps, Debbie Mitchell plus one yet to be elected. Past-president Robert Fawcett will also serve on the executive.

Deane was the BCIT Student Association president in his graduating year, during which time the campus centre, now under construction, was initiated; in his first year he was an SA member-atlarge.

The new president said he was confident about taking the position. "I feel I am well acquainted with the operations of BCIT.

"During a time of economic restraint BCIT needs all the friends it can get and some of its greatest friends are alumni," Deane commented.

The role alumni members can take to aid the institute was a prime topic of discussion among members.

Gordon Thom, BCIT president, explained BCIT was looking to sources other than government for funding.

"This is one area where alumni can be of great assistance," he said, "not so much in terms of dollars but in leadership in soliciting funds from corporations."

Thom also explained the formal procedure for members of the alumni to get involved was through the Educational

Council, on which alumni have two seats.

Robert Simons, a member of the BCIT Board of Governors, was presented with the annual alumni award "in recognition of perseverance and dedication displayed in ensuring that BCIT would stand out as a learning institute."

Simons was an alumni representative on the Board during 1979 and 1980, during which time he chaired the finance committee, and currently holds the status of a government appointee to the Board.

He graduated from BCIT in 1972 and has been employed with the BC Telephone Company for the past nine years.

Simons, too, addressed the aspect of fund-raising by members of the alumni, detailing the bursary fund which has been established through BCIT's vicepresident of finance.

"It's a hip pocket approach but it's been successful and I recommend this be a prime goal of the alumni," Simons said. Other discussion at the meeting noted the advantages of purchasing Alumni Association identification cards for five dollars.


Robert Fawcett pointed out that while membership in the association is by virtue of having graduated, it is useful for on-campus services.

Dean of Students Jerry Lloyd, who acts as a liaison between the institute and alumni, cited the fact the BCIT library is increasing its fee for external users from \$10 to \$25. "But the fee is waived for card holders," he said.

Fawcett said the association will investigate reduced fees for other services which could be made available to alumni.

Members were also told at the meeting that the Alumni Association's office is now located within the campus life trailer and were urged to visit.

January is now the projected date for the opening of the squash and racquetball courts in the new Student Association Activity Centre.


Other projects affected by the dispute are the four new student residences and the warehouse.

In May the Association donated two \$25.00 gift certificates to the Computer Technology's ten year reunion which, coordinator Frank Wegner advised, was a great success. Frank sent us a list of all who attended, which will aid in up-dating our mailing list.

On May 29th, the Association held an
