## EMPLOYER/FACULTY AND TECH STAFF JOINT COMPUTER PURCHASE PLAN

The Institute wishes to make available to individual full-time faculty and full-time tech staff the opportunity to become skilled in the use of computers. A sum of \$100,000 has been set aside from the 1987/88 budget year to assist full-time faculty and tech staff achieve this objective.

- 1. The Institute will pay 50% (up to a maximum of \$1000) of the basic cost of a computer package. This plan does not include software.
- 2. Because of the difficulty of providing maintenance and other support, the Institute must restrict the number of different types of computers available for purchase under this plan. Preference will be given to IBM or IBM compatible computers. You may submit a request for any type of equipment. However, Materials Management and Computer Resources with assistance from Education Council will shortlist from the requests received only three to five models for which a bulk purchase will be made. Those who have requested other types will be given the opportunity to change their selection or withdraw their request. Prices will vary depending on the package purchased and special discount negotiated by Materials Management.
- 3. The computer package will be the property of the Institute for a period of three years and will be inventoried by Computer Resources. After that period of time, ownership of the computer will transfer to the employee. While it is understood that the employee now owns the computer, the purchase was made for use at the place of work and therefore will remain at the Institute. The Institute will be responsible for maintenance and security while on campus.
- 4. The computer package will be permanently assigned to the faculty or tech staff member. The computer is expected to remain at the Institute during the school year. Computers being taken off-campus for the summer months must be signed out at Computer Resources. This requirement is necessary to monitor the whereabouts of Institute assets. It is not intended to be a restrictive mechanism.
- 5. A payroll deduction plan will be made available to employees who wish to take advantage of this plan. The term of the payments will extend over a one year period and the amount will depend on the price of the package purchased for that employee.

- 6. Staff Society members cannot use Professional Development funds for their portion of the acquisition costs of the computer.
- 7. Should the employee leave the Institute prior to the end of a three year period subsequent to the purchase, the employee may opt to buy/sell out the computer package at a prorated cost (33% per year) from/to the Institute.
- 8. Applications to access the funding must be forwarded to the Director of Computer Resources by October 30, 1987. If the demand is in excess of the funds available, a lottery will be held. If there are funds remaining, the Plan will be made available on a first-come first-serve basis to all Institute full-time employees.
- 9. This Joint Computer Purchase Plan will be effective immediately through to March 31, 1988 or until the fund is depleted. Faculty members or tech staff who, with their own funds, have purchased since April 1, 1987 a computer for use at the Institute, may be considered for this Plan. Each case will be reviewed on its own merit, but application must be made before October 30, 1987.
