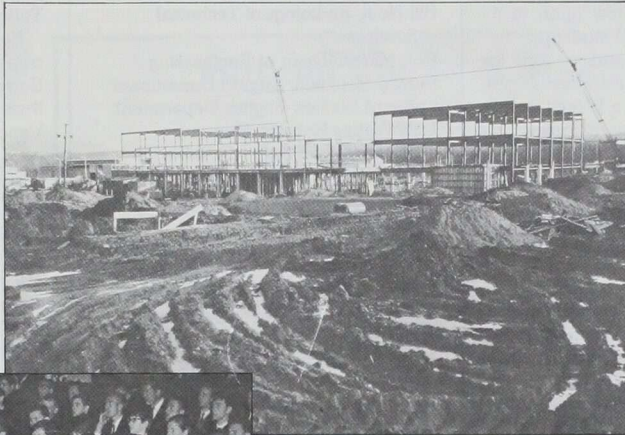


## BCIT's 20th ANNIVERSARY APPROACHES

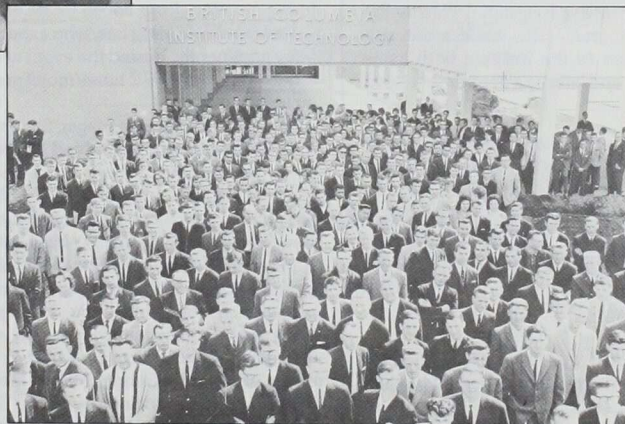

## NEW CONSTITUTION ... a summary

The Constitution Committee has been working on changes to the existing constitution to allow the Alumni Association to function more effectively.

Some of the changes are cosmetic but the major change will allow mail-in ballots for the election of officers and directors. This will mean that all alumni members may vote regardless of where they live.

The size of the Board of Directors will be increased by two people and, it is hoped that this will allow your association to get involved in more projects without adding workload to the individual directors. Also, officers and directors will be elected for two year terms to provide for continuity from year to year.

We are also proposing to decrease the quorum requirements for the annual meeting from 25 to 20. It can be difficult to get a quorum because the membership is spread throughout the world but the activity of the association should not be restricted simply because business cannot be conducted through lack of a quorum.

The position of Board of Governors representative has, in effect, been given a job description and the representative will become an ex-officio member of the Board of Directors of the Association. We are also proposing to have an ex-officio member representing the Student Association. There are a number of benefits to the Alumni Association, the Board of Governors, and the Student Association in having this kind of representation. It will provide a two-way communication that we have not had in the past.

The date of the AGM is proposed to be fixed for the month of May and the election of officers and directors is proposed by mail ballot. Fixing the month in May is intended to coincide with year end and nominations to the Board of Governors. Mail ballots will allow all alumni to vote regardless of their place of residence.

We feel that the changes are positive and will provide for a more effective association which can work for the benefit of the alumni.
