Letter to the Editor

In the January 26 edition of the UPDATE there was an interview with Roy Murray in which he responded to questions about the proposed reorganization. In the preamble to the interview the following statement was made by UPDATĚ: "The proposal is a

result of extensive internal and external consultation carried out by an Institute Education Committee struck at the time of the merger."

As a member of the Educational Consultative Committee, I must point out that the UPDATE statement is in error and is misleading. In fact, the proposal was presented to the Consultative Committee the day before it was released to the Institute community. That hardly constitutes consultation.

The day the proposal was tabled with the Committee they were poised to present their own proposed new organization to the President. The Committee's proposal and Mr. Murray's proposal are markedly different. The Committee's proposal called for five Schools (including the School of Academic and Vocational Studies), five Deans, Department Heads, and Departments. Mr. Murray proposes four Schools, four Deans, Associate Deans (i.e. elimination of Department Heads), Programs headed by Program Heads (i.e. elimination of Departments, Chief and Senior Instructors).

Discussion on Mr. Murray's proposal continues. If informed views on the proposal are to be sought, believe that the details of the proposal and the process

that led up to the proposal need clarification.
