Food service in the Electrical building will end Thursday, June 18 and resume again Tuesday, Sept. 8.


CAMPUS BRIEFS

Please note that requests for reimbursement of fees, materials, etc. for courses/ seminars where leave from work is not required may be exempt from the time limits.


However, all requests must be considered before the course is taken, not after it is completed.

Year of disabled grants available this month

Application forms are now available at BCIT for grants from the provincial government for projects relating to the International Year for the Disabled Person (IYDP).

Closing date for applications is May 29 and projects will be funded to a maximum of \$30,000 with exceptions for outstanding projects.

BCIT's disabled persons committee will be submitting a proposal as outlined in a story in *Developments* April 16 issue.

The BCIT committee is looking forward to the rapid acceptance of its recommendations, said committee member Gerry Weeks.

Some projects the committee hopes to fund are: a read/write machine and talking calculators for the blind and partially sighted: upgrading and brailling of campus signs and maps; and renovations to improve access to campus buildings for disabled persons.

Everyone is invited to see the library display of books,

pamphlets, periodicals, films, kits and tapes on the disabled person.
